Subject: SOPs/Guidelines for COVID Management in Leh district.

O R D E R

WHEREAS, the Secretary MoHFW, GOI vide D.O No. Z.28015/85/2021-DM Cell Dated 25-04-2021 has advised all District Magistrates to undertake containment measures to restrict intermingling amongst people so that spread of infection can be controlled.

WHEREAS, detailed assessment of the current COVID situation in Leh district has been conducted by the DDMA, Leh in light of current trend of COVID cases, Positivity Rate, and Hospital admissions etc., and are of the clear view of further extension of restrictions which are already in place to avoid further spread of the Corona Virus.

NOW THEREFORE, in view of the above, I, Shrikant Balasaheb Suse, IAS, District Magistrate, Leh in exercise of the power conferred upon me as Chairman, District Disaster Management Authority under section 34 of Disaster Management Act 2005, as well as under Section 144 CrPC, 1973, Epidemic Disaster Management Act, 1897, and in partial modification of this office order issued vide No. DCL/PS/COVID-19/OO/2021-1178 dated 21-05-2021, hereby order the following relaxations w.e.f. **07-06-2021 (Monday) 05:00 A.M.**, till **14-06-2021 (Monday); 05:00 A.M.**

1. All Shops/Business establishments/related movements shall be allowed as per the following details:

2. Restaurants shall be allowed to operate only for Home Delivery from 08:00 AM to 08:00 PM and no customers shall be allowed inside for takeaway or dine-in service.
3. Non Essential vehicular movement shall be allowed on ODD/EVEN pattern with **Monday, Wednesday, Friday** for vehicles with registration number ending with **ODD (1,3,5,7,9)** and **Tuesday & Thursday** for vehicles with registration number ending with **EVEN (0,2,4,8)** numbers, with **50% of seating capacity**.
4. Movement of govt employees shall continue as per previous order issued vide this office's order no. DCL/PS/COVID-19/00/2021-1178 dated 21-05-2021.
5. Hotels shall operate their dine-in facilities only upto **30% of their capacity** for their in-house guests only and room services shall be encouraged.
6. Public transport, Private offices, Salon/Barber shops/Beauty Parlours/ Spa/Gyms shall remain closed for all days.
7. Development activities and construction works shall be allowed with labourers residing within the work site, with all Covid-19 SoPs being followed (including double mask) and their unauthorised movement shall not be allowed.
8. The Weekend Curfew shall continue to be in force till further order, during which there shall be complete restriction on all kind of Activities/Movements including the Govt. Offices, except those mentioned at i & ii of Table at S.No.1.
9. The Night Curfew for non-essential services shall continue to remain in force for all days between 09:00 PM to 05:00 AM.
10. The relaxations allowed in this order shall not extend to areas notified as containment zone in entire district.

The Sr. Superintendent of Police, Leh and Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), ARTO, Traffic Police, Sub Divisional Magistrates, Executive Magistrates 1st class, COVID SOPs Enforcement Squads shall ensure implementation of the above directives in letter and spirit.

Any violation of the above directives, penal action under Section 51 of Disaster Management Act., 2005 and Section 188 of IPC, and other relevant laws shall be initiated.
